At this point in the meeting Mr. Olson talked about creating ability-based choir groups opposed to age or grade level based groups. Mr. Olson said the Principal Mr. Fredrickson does not agree with this philosophy. For the Choir Mr. Olson would like to have the kids go to a Broadway musical, and he would also like the choir kids to go on a singing tour.

ANNUAL MEETING

Jean Krukowski discussed interest in positions for the Executive Board, which included herself for President, Theresa Dalen for Vice President; Cynthia Overson for Secretary; and after a great deal of discussion Tina Brown for Treasurer. Susan Morimoto nominated Cynthia Overson for the position of Secretary, Jean Krukowski seconded the nomination, and the Board voted Cynthia Overson for the position of Secretary by a unanimous yeah vote. Nancy Parris nominated Tina Brown for the position of Treasurer, Pete Parris seconded the nomination, and the Board voted Tina Brown for the position of Treasurer by a unanimous yeah vote. Teresa Dalen was nominated for the position of Vice President, the nomination was seconded, and the Board voted Teresa Dalen for the position of Vice President by a unanimous yeah vote. Pete Parris nominated Jean Krukowski for the position of President, Barb Bostic seconded the nomination, and the Board voted Jean Krukowski for the position of President by a unanimous yeah vote.

Nancy Parris discussed a \$5500.00 difference in trying to balance bank statement against the operating statement. Having a bank statement to balance against is a newly acquired responsibility that the board has to take over from the district this year, due to a State mandate. Nancy also explained that the surplus that we have been working with in Power

Company, are actually dollars from dormant accounts that should be in Choir. Nancy suggests that we need to get actual numbers to work with before deciding to go forward.

Show Choir Rehearsals on Sunday Afternoons? Next year we will try to avoid Sunday Rehearsals. The Sunday Practices that are scheduled from 9-5 will be shortened, and will eliminate at least one for this year. Discussed options for alternative practice scheduling.

Mr. Olson would like everyone to feel comfortable approaching him with their concerns.
